- 1. Motor Design** : DC brushless 4 pole motor design.

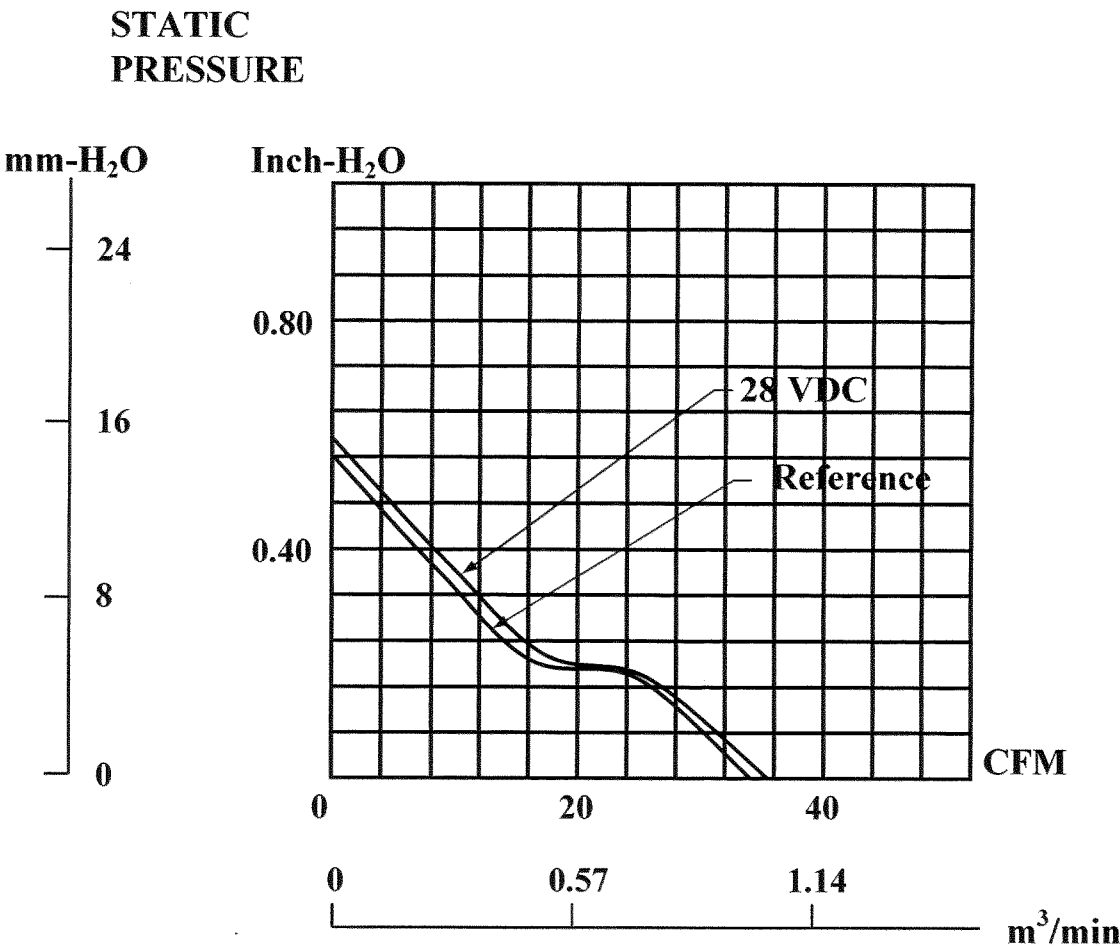

After these 2 tests, which executing by regular standard, the fan will be measured the performance is normal or not.

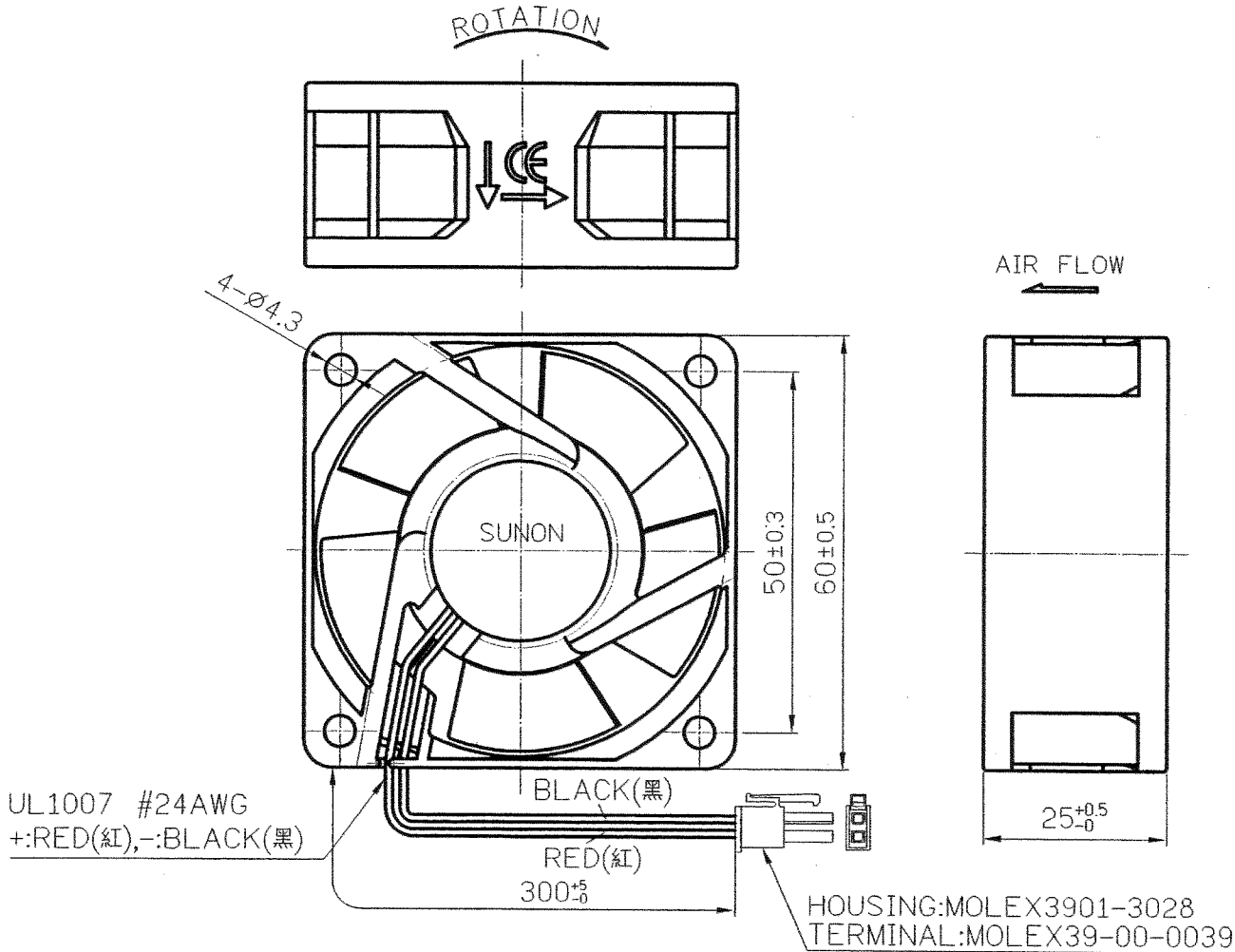
PERFORMANCE CURVES
