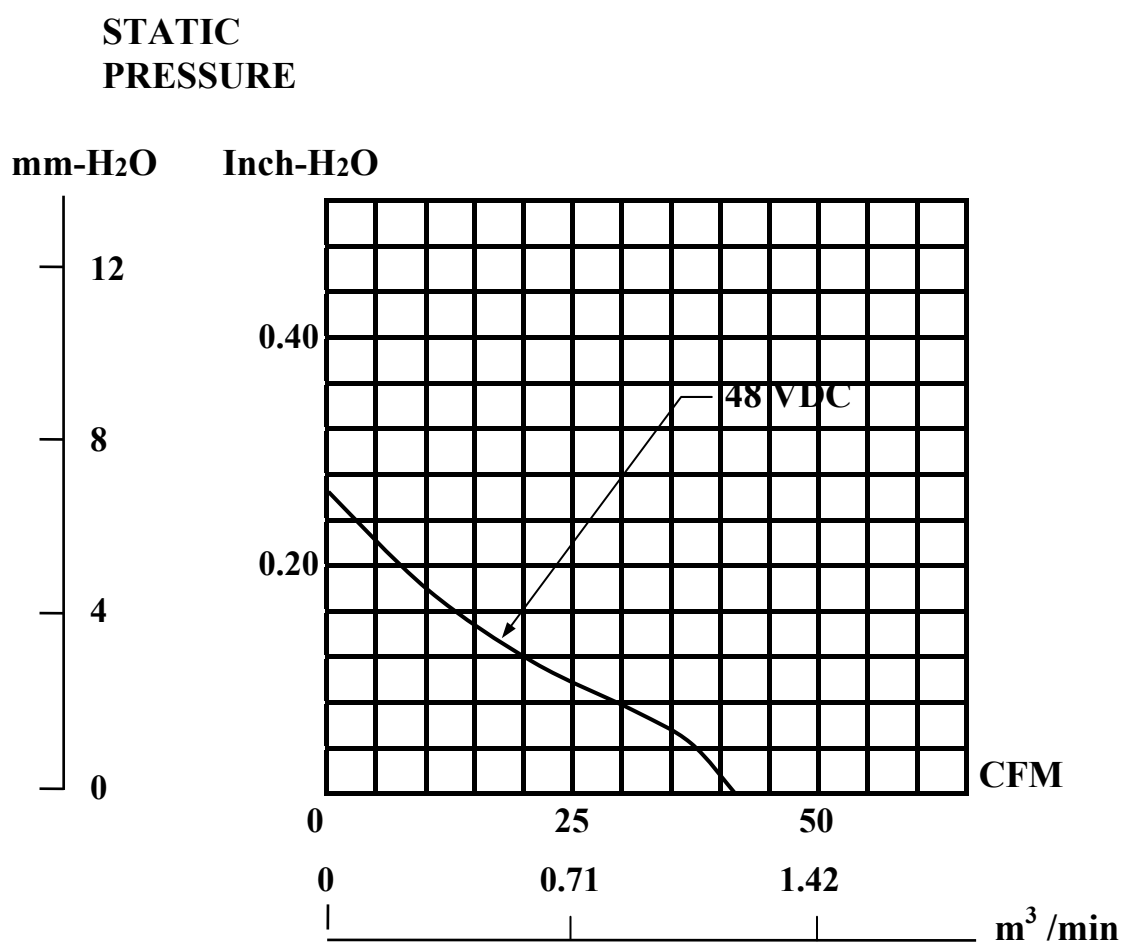

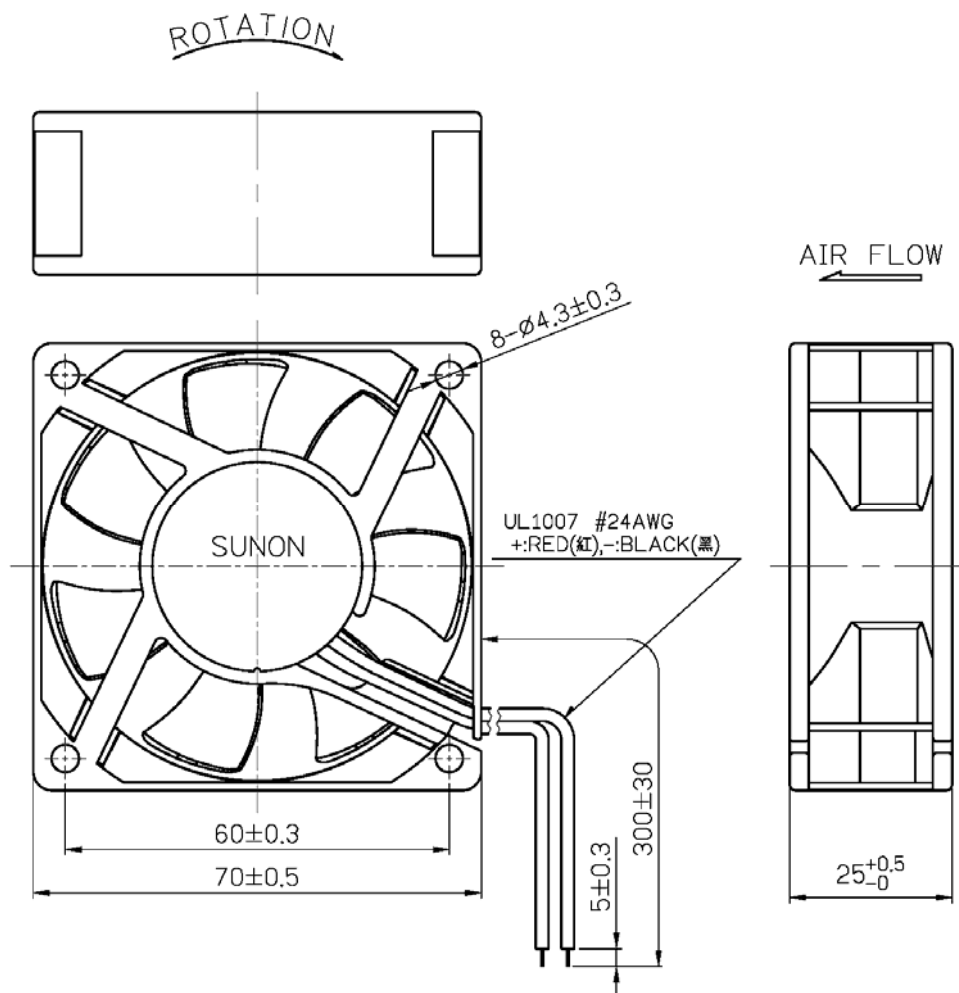
PERFORMANCE CURVES
